**AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN FRANKLIN COUNTY AND THE

WHEREAS, pursuant to RCW 36.01.010 and RCW 36.32.120 the legislative authority of each county is authorized to enter into contracts on behalf of the county and have the care of county property and management of county funds and business; and

WHEREAS, pursuant to RCW 39.34 the Interlocal Cooperation Act permits local governmental units to make the most efficient use of their powers by enabling them to cooperate with other localities on a basis of mutual advantage and thereby to provide services and facilities in a manner and pursuant to forms of governmental organization that will accord best with geographic, economic, population, and other factors influencing the needs and development of local communities; and

WHEREAS, the Board of Franklin County Commissioners approved the Interlocal Agreement Between Franklin County and the City of Connell for District Court Services by Franklin County Resolution 2010-263 on September 8, 2010; and

WHEREAS, the Board of Franklin County Commissioners constitutes the legislative authority of Franklin County and desires to enter into the attached Amendment to the Interlocal Agreement between Franklin County and the City of Connell for District Court Services as being in the best interest of Franklin County; and

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners hereby approves the Amended Interlocal Agreement between Franklin County and the City of Connell for District Court Services.

**AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN FRANKLIN COUNTY
AND THE CITY OF CONNELL FOR DISTRICT COURT SERVICES**

THIS AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN FRANKLIN COUNTY AND THE CITY OF CONNELL FOR DISTRICT COURT SERVICES ("Amendment") is made this 18 day of December, 2017, by and between the CITY OF CONNELL, a municipal corporation, hereinafter called "City," and FRANKLIN COUNTY, a political subdivision of the State of Washington, hereinafter called "County."

WHEREAS the City and County entered into an Interlocal Agreement for District Court Services on the 8th day of September, 2010 (the "Agreement"); extended by an amendment through December 31, 2017; and

WHEREAS the City has requested that the County continue to provide the services of its district court system to the City pursuant to the Agreement as authorized by RCW 39.34.180; and

WHEREAS the County is in agreement to continue to provide the services of its district court system; and

WHEREAS the Agreement provides that it may be extended by the mutual written agreement of the parties; NOW, THEREFORE;

IT IS AGREED between the City and the County that the term of the Agreement be modified to provide that the Agreement shall remain in effect through December 31, 2020 unless earlier terminated pursuant to the terms of the Agreement; and


